

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **4.54** tCO₂e by 20**29**. This is a reduction of **22.7**%. It is forecast that as NWT grows it will go from a virtual working company to operating out of an office in 2025 increases its CO2 footprint by a factor of three (**FY23 102 tCO2e** to **FY25 279 tCO2e**), however through abatement and offset schemes NWT commits to reducing these emissions to **FY29 15.45 tCO2e** and being **carbon neutral by 2030**.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the **2023** baseline. The carbon emission reduction achieved by these schemes equate to **78.919** tCO₂e, a **100**% reduction against the prior year where no reduction initiatives where implemented.

Without any Scope 1 & 2 emissions due to the virtual working nature of the NWT business, carbon reduction measures are limited to offset schemes. These measures will be in effect, and will be continuously invested in, when performing the contract.

NWT has partnered with an ESG specialist consultancy, transformacy and offsetting company Switch2Zero who only invest in UN and Gold Standard Offsetting Programmes. Switch2Zero blend the offset investments on behalf of NWT and are recorded on the Switch2Zero public leger.

In the future (aiming for 2024) NWT hopes to implement and conform to ISO14001 certification.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹³ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting¹⁴.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard¹⁵.
